1. Gauriganj rural municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Truss Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
2. Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five Truss bridges within last five years are eligible for the bidding. New fabricators may also apply in joint venture with an eligible fabricator having the required experience. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the minimum requirements.
